Ted is a graduate of Stanford Law School, J.D. (1972), and Princeton University, A.B. cum laude (1966) & licensed before the Hawaii State Bar, U.S. Federal Ct, D. Hawaii, & the Ninth Circuit, U.S. Supreme Court. His interests include reading, woodworking, U.S. Constitutional law, gardening, theater and cinema, and photography. He said he had the best job, & the ability to do things for people to make things right. Retired at 60 in 2004, he spent time with his wife; she was the love of his life. A programmer with McKesson and Robins, his one son is about to have a baby girl named Lilly Gretchen - his wife's name! They are doing well & he will see them in June. His son calls him every night to make sure he's still kicking. Ted remarked, "I'm glad to be here with this group with military connections".

## SERVICE PROJECTS

### Aiea Elementary School Art Project (artsonia.com)

VP **John McLaughlin** is working with the kids at Aiea Elementary. Each young artist will draw their depiction of a flower from Hawaii for their counterpart Japanese students that were affected by the recent earthquake and tsunami The pictures will be sent to the Tokyo Osaki Rotary Club, who will assist John in getting them to elementary schools in Tokyo.

## PROGRAM

Jeff Deer introduced Past District Governor Lisa Foster (East Honolulu). Lisa's been active in humanitarian service since 1996, as her Club President 2000-2001 & at the club, District & Zone levels, as a Rotary Volunteer to Southeast Asia and in Ethiopia helped immunize children against Polio. Lisa was recognized by her Rotary Club as Employer of the Year and received the Four Avenues of Service Award. A graduate of the U of H, the University of San Francisco, she obtained a doctorate degree in educational leadership from BYU in Utah. The principal at Star of the Sea Early Learning Center and an adjunct instructor at Chaminade University, Lisa's passions are serving youth through education and promoting peace and hope in the world through Service Above Self.

**Lisa** spoke of the Cambodian genocide of 1975-1979, in which approximately 1.7 million people lost their lives (21% of the country's population) and was one of the worst human tragedies of the last century.

### Future Light Orphanage

Through her work with Rotary, **Lisa** became an Email Foster Parent and adopted a sister and brother . The first seeds of the partnership between eGlobal Family (Formally Email Foster Parent) and Future Light Orphanage (FLO) were planted in the year 2000 when Rob Hail, PP of The Rotary Club of Honolulu Sunrise, first visited FLO and met founder and director Phaly Nuon and the children of the orphanage. At that time fewer than one hundred children were living there, in an environment that was safe and loving, yet which could provide only the bare minimum of resources. All of the children slept side by side on the floor in two rooms; two meager meals were provided per day with very basic education.

Email Foster Parents, along with other very generous donors, furnished these children with emotional and financial support. Today there are over 200 children living at FLO, & another 150 children from the nearby



village who come to FLO each day to receive supplemental education. The orphanage "campus" now includes a fourroom schoolhouse, a library built by Honolulu Sunrise. and separate boys' and girls'

Aloha Learning Center spearheaded by PDG Hal Darcy & Metro, built by the Rotary Clubs of Hawaii, and Rotary International

dorms & the Aloha Learning Center built by Metro. The children receive three meals per day and have ade-

quate medical & dental care. There are now over 40 FLO children attending university other or postsecondary institutions. Over the years, Email Foster Parents and their Children Foster developed have

extremely close bonds. Many Foster Parents have visited and volunteered at the orphanage, a life-changing



experience for both the children and their sponsors. Nearly all of the FLO children have been matched with loving Email Foster Parents and exchange emails and photos with them

*Computer Room* photos with them regularly. The relationships that have blossomed be-

tween the kids and their foster families have been transformative for all involved. 30 FLO dance and music students came to Honolulu for two weeks in 2008, stayed with their email foster parents & performed at Mamiya Theatre. Freeman scholarships were awarded to a FLO student in 2008 & 2009 to attend Punahou's Pan Pacific Program.
